FROM THE CHAIRMAN'S DESK

We are all here to serve, not only our Association, but the bigger South African Professional Hunting Industry. The very reason for CPHC's existence is you; our members. As a membership organisation, Custodians depends on every member to participate wherever you can and to be a CPHC Brand ambassador. I therefore also encourage you to share ideas or concerns you might have with us.

I also want to take the opportunity to thank those of our members who have paid their 2024 membership fees. Membership runs from 1 January to 31 December and if you have not settled your account yet, I encourage you to do so as soon as possible. Our full and field membership includes SATIB EVAC-911 cover and it would be extremely important for you to ensure you are covered before starting with the hunting season.

We have emphasised at our last two AGM's, the importance of building and retaining sound relationships with other local and international organisations, relevant government departments and tourism agencies. I believe our attendance at the DSC and SCI Conventions this vegr were extremely valuable. It provided our CEO, and some of our EXCO members, the opportunities to engage with stakeholders and representatives from various organisations and we look forward to strengthening our relationships with them in the near future. Adri has shared some of the interactions we've had in her report.

We have already seen various challenges in the year, which included the uncertainty about an apparent moratorium on the issuing of temporary firearm import permits between SA, Mocambique, EswatIni and Lesotho. Although no written Directive was ever distributed; a verbal communication from the CFR, at the end of January, was circulated that no permits will be issued.

This was of great concern and Hermann has, amongst others, reached out to Col. Seshwene from the Central Firearms Registry for more information regarding the verbal Directive. We have since been informed, via verbal communiqué, that the apparent moratorium has been lifted at the time of writing this message. A few permit applications have been handed in and we are awaiting the outcome.

We have also been made aware of USFWS's review for the possible listing of Hippopotamus on the Endangered Species Act. Adri is in the process of gathering information to finalise our comment to USFWS and I urge anybody with information, to please contact her.

We have been informed of the ban on import of all CITES I and some CITES II species trophies into Belgium and that France and Germany are also considering similar actions. We will keep you informed as we receive more information, but we can certainly expect more challenges during the year. I want to give you the assurance that we will do our level best to work together with other stakeholders in our industry to address these as and when they arise. In the short term, we trust that the Department will soon commence with the public participation process for hunting quotas on elephant, rhino and leopard and we will inform our members as to when this will commence.

On a positive note, Custodians received an invitation to attend the Biodiversity Indaba & Investment Summit at the end of March. The objective of the Summit is to create a platform for dialogue amongst biodiversity, conservation stakeholders and various financial institutions invited attend. President Ramaphosa will address the Summit on the last day and feedback will be given to members at the appropriate occasion.

We will also, together with PHASA, SAHGCA and WRSA assist the Department, and SCIF, with arrangements for the African Wildlife Consultative Forum to be hosted in South Africa at the end of October.

With the hunting season upon us, I wish you good luck and thank you for your continued support as a Custodians member and ambassador.

DSC CONVENTION 2024



Custodians once again had a booth in the combined OPHAA booth, together with PHAZ and ZPGA and an unmanned NAPHA information desk. All organisations also acknowledged the importance of good connections and relationships with our governmental departments and communities to create positivity. This will be discussed by EXCO to decide on a method to determine the impact we have on habitat protection and community involvement as a collective.

Sean Kelly and I once again had the privilege of attending the Congressional Sportsmens' Foundation (CSF) cocktail. The CSF is a 501 non-profit organisation headquartered in Washington, DC. Established in 1989. CSF's mission is to "work with Congress, governors, and state legislatures to protect and advance hunting, angling and recreational shooting."

6.SATIB/EVAC 911

- Custodians and SATIB Insurance Brokers reached an agreement last year, to offer emergency medical evacuation insurance as part of an exclusive membership benefit to professional hunters and field staff that are members of the Custodians.
- This agreement includes access to SATIB24 Crisis Call, for all Custodians members and their staff with membership, for injuries and incidents incurred whilst providing services to their clients, whether in camp or actively on the hunt:
- SATIB's incident management includes the SATIB24 Crisis Call which offers:
- *emergency evacuation and repatriation;
- *medical emergency;
- *accidental death;
- *permanent disability;
- *income protection for disability;
- *hospitalization;\
- *life support equipment;
- *search and rescue;
- *quadriplegia, disfigurement and trauma.

5.TOYOTA

LATEST ON THE APPARENT MORATORIUM: TEMPORARY FIREARM IMPORT OR IN-TRANSIT PERMITS: MOCAMBIQUE, LESOTHO, ESWATINI

Although there was no official media statement from the Central Firearms Registry and SAPS, we became aware of an apparent moratorium at the end of January that no temporary export or intransit permits will be issued by SAPS at CFR, OR Tambo or border posts for international clients or RSA citizens traveling with firearms to these countries until further notice. Other than liaising with CFR and looking into legal issues, we have also liaised with PHASA and outfitters in Mocambique. We have all agreed to keep each other informed of any information that anyone might obtain.

We have subsequently been informed verbally by CFR and by PHASA, based on correspondence that they have received from the CFR, that the status regarding the issuing of firearm import permits are OR Tambo International Airport will remain, with the CFR remaining the regulatory authority of all types of permits). Furthermore, that applications for temporary firearm import permits, may be considered by the office of the Central Firearms Register. Applications will be considered based on presentation, appropriateness and adequacy of all legally required documentation from the applicants.

We are also aware of some of our members who have since had positive responses to their clients' temporary firearm import permits.

US FISH & WILDLIFE SERVICES' REVIEW ON HIPPO

During March 2022, the USFWS received a petition from The Humane Society, requesting that the common hippopotamus be listed as a threatened species or an endangered species under the Endangered Species Act.

The USFWS will now evaluate the potential threats as listed by the Humane Society and others.

Custodians will request the Scientific Authority of South Africa for updated information regarding hippo, to include in our comments to the USFWS.

SATSA recognises that news about cholera outbreaks in Southern Africa may raise questions for travel and tourism professionals. It's essential to be equipped with accurate information to reassure clients and maintain confidence in the region.

KEY POINTS FOR TOURISM PROFESSIONALS:

Key points for tourism professionals:

- Localised outbreaks: Outbreaks are occurring in certain countries within Southern Africa and not across the entire region. Stay informed about specific affected areas.
- Minimal risk for tourists: The risk of tourists contracting cholera remains low when adhering to standard hygiene practices.
- Focus on prevention: Emphasise the following to clients:
- Safe water and food consumption (bottled water, cooked food, etc.)
- Strict hand hygiene practices
- Consider recommending cholera vaccination if appropriate for the client's itinerary
- Stay aware: Monitor reliable sources for updates:
- World Health Organization (WHO) Africa Region: https://www.afro.who.int/ (search for "cholera")
- ReliefWeb: https://reliefweb.int/ (search for "cholera Southern Africa")
- National Institute of Communicable Diseases (South Africa): https://www.nicd.ac.za/diseases-a-z-index/cholera/

The situation in South Africa

- South Africa experienced isolated outbreaks in 2023, contained without a national emergency declaration.
- Very few cholera cases have been reported in South Africa (less than a dozen), with the majority being imported
 cases related to travel to and from endemic countries with outbreaks.


